Agenda Item #1: Review Previous Months Summary Including Follow-up

  - **a.** –January Minutes were reviewed.
  - -December Safety Agenda Item #4: Construction Update: Speaker in Speech Room: The work has been completed. A speaker has been installed in the nurse's office as well.
  - -January Safety Agenda Item #4: Sticky Latch on the Exit #2 Door: The work has been completed.
  - -January Safety Agenda Item #5: Ongoing Issue Regarding Traffic Infractions Around PS 174: The locations of sample "pinlight flashing" stop signs were not found. - **a**. In the 19-20 school year there will be a total of 12 Emergency Drills: 4 Lockdown Drills & 8 Evacuation Drills.
- -To date 8 Emergency Drills have been completed.
- -All the fall term bus drills have been completed.
- **b**. -There are 4 Emergency Drills that need to be completed before the end of the year: 3 Evacuation Drills & 1 Lockdown Drill.
- -The spring term bus drills must be conducted between 3/1 & 4/30.
- **c**. -The school will comply with the mandates in a timely fashion.
- -The spring term bus drills will be completed by 4/30.

### Agenda Item #3: Construction Update: AC

- **a**. An auditorium AC unit is being added to the building. During the work on this project, the roof was damaged which caused a leak and then flooding in the auditorium. The roof was repaired and the auditorium cleaned.

- **c**. a. The sign "Students Only Adults Must Enter At The Main Entrance" will be placed at the arrival entrance.
  - b & c. Security and office personnel will be notified of this policy.
